#### 1. INTRODUCTION:

#### 9. CONTRACT PERIOD:

9.1 Six months from the date of issuing Work Order.

#### **10. ESSENCE:**

10.1 Time of completion of the work is the essence of the contract. Penalty clauses shall be applicable as per terms and conditions of the tender.

#### **11. GENERAL CONDITIONS:**

- 11.1 To view Tender Notice, Detailed Time Schedule, Tender Document for this Tender and subsequently purchase the Tender Document and its supporting documents, kindly visit the website of MSMCL <u>www.msmc.gov.in</u>. - 11.5 The Managing Director reserves the right to accept or reject any or all offer(s) without assigning any reasons thereof.
- 11.6 The Bid submitted must remain valid for a period of Six months from the Bid opening date.
- 11.7 MSMCL will satisfy itself that the tenderer is experienced, reputed and possesses the requisite qualifications by perusing details submitted with Cover-B. The decision of the MSMCL in regard to qualify any of the tenderers will be final and binding on all the tenderers.
- 11.8 MSMCL is not under any obligation to accept the lowest bid / bids and reserves the right to reject any or all the tenders without assigning any reason whatsoever.

#### **12. OPENING OF TENDER:**

- 12.1 Tender shall be opened on the date and time specified in the tender document. Bidder or its authorized representative is encouraged to be present at the time of opening of tender.
- 12.2 **Technical Bid:** It will be opened to verify its contents as per requirements on the date specified in Tender Notice in presence of bidder/s or their authorized representative. Decision of the Tender Opening authority shall be final in this regard.
- 12.3 **Price Bid:** Technical Bill shall be evaluated and the date of opening of 'Price Bid' shall be intimated to the eligible Tenderers. Prize Bids of technically qualified tenderer shall only be opened.

#### **13. EVALUATION OF TENDERS:**

- 13.1 After opening of Technical Bid on the scheduled date and time, tender opening committee shall examine the contents of the tender received along with all prescribed mandatory document(s).
- 13.2 The tender opening committee shall scrutinize the document(s) mentioned above for its eligibility, validity, applicability, compliance and substantiation stipulated in tender document.
- 13.3 The technical scrutiny shall be on the basis of submitted substantiation document(s).
- 13.4 Any tender during the evaluation process do not meet the tender conditions laid down in the tender document will be declared as not acceptable and such tenders shall not be considered for further evaluation.
- 13.5 Tenders which are in full conformity with tender requirements and conditions shall be declared as eligible.

#### 14. AWARD OF CONTRACT:

- 14.1 MSMC will award the work to the successful bidder whose tender shall be determined to be substantially responsive and determined as lowest evaluated tender, provided further that the tender is determined to be qualified to perform the work satisfactorily.
- 14.2 Bidder quoting the lowest offer will be informed about the intention of award by sending an acceptance letter and shall have to sign an agreement with MSMC and shall submit the Security Deposit of 10% of the total contract value within 7 days after signing of contract.
- 14.3 After completion of above stages, MSMC shall release the Work Order.
- 14.4 MSMC reserves the rights to cancel or revise any or all of the tender or part of tender without giving any reason thereto with no cost to MSMC.

#### **15. PERIOD OF CONTRACT & LIQUIDITY DAMAGE:**

- 15.1 Contract to be completed within six months from the date of issuance of the Work Order.
- 15.2 Contractor/RQP must have to submit draft copy of Mining Plan/Scheme of Mine within 60 days from the date of issuance of Work Order.
- 15.3 Final approval from the Competent Authority must be obtained within 6 (six) months from the date of issuance of Work Order.
- 15.4 In case of delay in getting approval from the competent authority due to the failure of RQP, a liquidity Damage (L.D.) may be levied at the rate of Rs. 500/- per week for the delayed period.

#### **16. FAILURE OF TENDERER:**

- 16.1 If the tenderer fails to complete the works, and as a result, the order is cancelled, the amount due to him, on account of work executed by him, if payable, shall be paid to him, only after due recoveries, as per the provision of contract, and only after alternative arrangement to complete the work have been made. The tenderer shall be liable to pay any loss by way of extra expenditure or other incidental expenses, which the corporation may sustain on account of such alternate arrangement at the risk and cost of the tenderer.
- 16.2 In the event of extension, liquidated damages, will be applicable.
- 16.3 In addition to action above, the corporation may propose the defaulting firm for blacklisting from future tenders.

#### **18. SPECIFIC TERMS & CONDITIONS:**

- 18.1 The Contractor/RQP shall be liable for preparation of Mining Plan/Scheme of Mine as per prescribed format of IBM, Ministry of Mines together with Plans & sections.
- 18.2 He shall also bear the cost of submission fee required to be paid to the competent authority.
- 18.3 He shall be liable for collection of information required for incorporation in Mining Plan/Scheme of Mine as per guidelines/ Circulars issue by IBM.
- 18.4 He shall carryout mine survey and prepare surface/geological plans on scale as per rules.
- 18.5 He shall estimate reserves as per UNFC guidelines to incorporate in document.
- 18.6 He shall discuss in detail with MSMC, the five year future proposals and mitigating measures which have financial bearings to be incorporated in Mining Plan. He shall include those proposals/ measures finalized by the MSMC.
- 18.7 Before submitting the draft copy to the Competent Authority, he shall submit soft copy to MSMC for further necessary corrections and verifications.
- 18.8 He shall accompany the inspecting officer of IBM during inspection and to answer satisfactorily any query raised by him.
- 18.9 He shall be made available for technical discussions with the IBM officials, inspecting officer as and when required.
- 18.10 He shall attend all scrutiny comments communicated by the IBM, satisfactorily.
- 18.11 The final approval of Mining Plan/Scheme of Mine w. r. t. Dongargaon Fluorite Mine, Area: 31.22 Ha At: Dongargaon, Taluka: Warora, District: Chandrapur, Maharashtra is required to be completed within six months from the date of issuance of work order.
- 18.12 Reports/documents/information available in MSMC office will be provided to him for reference.
- 18.13 During inspection of mine or discussion with IBM Officials, any deviation, violation of rules observed, he shall immediately inform to MSMC in writing for corrective measures.

- 18.14 Due to technical delays, time extension will be decided by committee on the final approval from Hon'ble Managing Director, M. S. M. C. Ltd.
- 18.15 Age criteria for RQP shall be below 65 years.

- 18.18 The Corporation reserves the right of accepting the tender either in whole or part, and the tenderer shall be bound to execute the same at his quoted rates.
- 18.19 MSMC will not pay any expenses of lodging, boarding and travelling.
- 18.20 MSMC will return the security deposit without any interests, after three month from the date of completion of work/contract period.
- 18.21 Qualified bidder will have to sign the agreement with MSMC.
- 18.22 Future government rules will be applicable to bidder.
- 18.23 Conditional tender shall be summarily rejected.

#### **19. RESOLUTION OF DISPUTE:**

19.1 In the event of any question, dispute or differences in respect of contract or terms and conditions of the contract or interpretation of the terms and conditions or part of the terms and conditions of the contract arises, the parties may mutually settle the dispute amicably.

#### **20. GOVERNING LANGUAGE:**

20.1 English language version of the contract shall govern its interpretation.

#### **21. APPLICABLE LAWS:**

21.1 The tender shall be governed with the law prevailing in India, Acts, Rules, Amendments, Notifications, Circulars, Orders, etc. made thereon from time to time.

#### 22. INDEMNIFICATION:

22.1 The Contractor shall indemnify the corporation (MSMC) against all the actions, suits, claims and demand or in respect of anything done or omitted to be done by contractor in connection with contract and against any losses or damages to the corporation in consequence of any action or suit being brought against the contractor for anything done or omitted to be done by the contractor in the execution of the contract.

#### **23. JURISDICTION:**

23.1 All the suits arising out of the contract shall be instituted in the court of competent jurisdiction situated in Nagpur only.

#### 24. SAVING CLAUSE:

24.1 No suits, prosecution or any legal proceedings shall lie against the any member of Tender Committee for anything that is done in good faith or intended to be done in pursuance of tender.

#### **25. CONFIDENTIALITY:**

25.1 Information relating to the examination, clarification, evaluation and comparison of tenders, and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not officially concerned with such process until the notification of Contract award is made. Any effort by the bidder to influence the purchaser in the bid evaluation, bid comparison or contract award decisions may result in the rejection of the bidders bids.

#### **26. FORCE MAJEURE CLAUSE:**

- 26.1 If in the event, the agency to the contract is prevented from discharging its/their obligations under the contract by reason of one or more of the event, such as arrest(s) by Government or people, blockade(s), revolution(s), insurrection(s), mobilization(s), strict(s), block-out(s), civil commotion(s), accident(s), Government order(s) or statutory action(s), natural calamity(ies), act(s) of God, or any cause of whatever nature or description beyond the control of the corporation (MSMC), then the agency shall have no claim whatsoever, against the corporation for any loss, damage cause to the agency by such reasons.
- 26.2 On the occurrence of any of the force majeure condition, the concern party shall notify the corporation in writing of such occurrence within 10 days of occurrence stating therein the date of occurrence of force majeure disability by registered letter duly certified by the statutory authority(ies).
- 26.3 The agency shall resume the work as soon as practicable after such eventuality has ceased to exist of which the corporation shall be the sole judge.
- 26.4 In the event of delay lasting over one month, if arising out of Force Majeure, the bidder will not claim extension in completion due for a period exceeding the period of delay, attributable to the causes of Force Majeure and neither the Corporation nor the bidder shall be liable to pay extra costs, provided it is mutually established that Force Majeure conditions did actually exist.

#### 27. CORRUPT OR FRAUDULENT PRACTICES:

- 27.1 MSMC as well as bidder shall observe the highest standard of ethics during the execution of such contract.
- 27.2 'Corrupt Practice' means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the Tender Process or in contract execution; and
- 27.3 'Fraudulent Practice' means a misrepresentation or omission of facts in order to influence the tender process or the execution of a contract to the detriment of corporation and includes collusive practice among bidder (prior to or after tender submission) designed to establish tender prices at artificial non-competitive levels and to deprive the corporation of the benefits of free and open competition.
- 27.4 'Collusive Practice' means a scheme or arrangement between two or more bidders, with or without the knowledge of the Corporation, designed to establish tender prices at artificial & non-competitive levels and
- 27.5 'Coercive Practice' means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the sale process or effect the execution of the contract.
- 27.6 MSMC shall reject a tender for award, if it determines that the bidder recommended for award has directly or through an agent engaged in corrupt or fraudulent practice in competing for the contract in question.
- 27.7 MSMC will declare a firm or individual as ineligible, either indefinitely or for a stated period of time, to be awarded a contract, if, it at any time determines that they would have directly or through an agent, engaged in corrupt, fraudulent, collusive, or coercive practices in competing for, or in executing a contract.
